

# The Light at the End of the Travel Data Tunnel



In the pit of your stomach lies the gnawing possibility that one department has already burned through the majority of the T&E budget. You just can't see it.

### INTRODUCTION

It's the end of the quarter. Next month, the sales team is planning a cross-country travel "extravaganza" in an effort to attract a new customer segment. The plan looks good on paper, but in the pit of your stomach lies the gnawing possibility that one department has already burned through the majority of the sales team's travel and entertainment (T&E) budget. You just can't see it. So, betting on your gut, you e-mail questions to your finance team asking for details. They send back their answers which likely create more questions than get resolved. It could take weeks before you have a data-backed recommendation and by that time, it's too late to ground the campaign or confidently approve liftoff.

If this sounds familiar, find some consolation in the fact that you're not alone. According to the T&E Expense Management research study conducted by the Aberdeen Group (February 2012), a whopping 69% of companies surveyed do not have real-time visibility into T&E spending against budget, and another 57% do not have the capability to identify what specific areas incurred expenses (airfare, lodging, meals, etc.). Response to a January 2013 CFO.com research study was similar, identifying that the single largest barrier to accessing robust, timely, and comprehensive information on travel expenses is a lack of integration among different systems and processes.

With today's workforce becoming more dispersed and global, it should come as no surprise that travel and expense-related costs typically make up anywhere from 7-12% of the overall operating budget (Aberdeen Group, March 2012). In most organizations, that represents the second largest line item on the company budget, right after salary expense. With numbers like that, it's no wonder finance teams are compelled to design Herculean-style workarounds to get to the details behind that elusive line item.

But it doesn't have to be that way. In this paper, we highlight some of the commonalities among what the Aberdeen Group coins the "best-in-class" pillars of expense management, and show how modern technology and optimal system integration from Concur® can help both travel managers and finance teams better manage what has historically been difficult, if not impossible, to measure.

According to the Aberdeen Group's research, companies that are seen as "best-in-class" have 85% of their business travel spend under management—meaning that the majority of their planned travel spend is "actively managed and accounted for in their corporate budgeting, planning and forecasting processes." Contrast that with the 19% under management in the bottom 30% of companies surveyed. This group, coined "laggards," has a lot of data and digits unaccounted for. According to the study, technology plays an important role in where organizations fall on the spectrum.

### THE ROLE OF TECHNOLOGY IN EFFECTIVELY MANAGING T&E

One of the five characteristics that the top organizations share is their use of technology. 82% of the "best-in-class" organizations have an end-to-end expense management solution in place, compared to 32% of the "laggards." Because T&E expenses are the second largest controllable expense in many organizations, the way you manage them must be effective, not simply pass inspection. Would you try to fix a leaky pipe with chewing gum if the proper plumbing materials and tools were at your disposal? Of course not. When it comes to managing travel and expenses, choices exist as well.

Few will dispute the fact that ERP systems have become extremely powerful and comprehensive as more and more functionality is integrated—from HR and CRM to travel and expense management. But often this robust functionality comes at the expense of simplicity and usability for the end user, requiring organizations to change their processes to accommodate the system instead of the other way around. If you want in-policy travel and accurate, on-time expense reports, you need a system that makes sense for the user. Best of breed travel and expense management systems, like those from Concur®, are designed specifically to be flexible and accommodate the diverse needs of global organizations and their business travelers.

Concur Travel & Expense, for example, helps organizations save time and control spend during every step of the business traveler's journey—before, during, and after the trip. #### **PROOF IN NUMBERS**

Saying that these solutions help save time and money is one thing, but the story the numbers tell is even more compelling. An October 2012 commissioned study conducted by Forrester Consulting on behalf of Concur examines the total economic impact and potential return on investment (ROI) that organizations may realize by deploying Concur's travel and expense management solution. According to the study, companies interviewed using integrated travel and expense from Concur experienced the following results:

- 50% reduction in expense reporting costs
- · Average net savings of \$1.2M
- Incremental labor productivity gains of \$125,000
- Reduction in out-of-policy expenses of nearly \$115,000
- Reduction in travel booking expenses of almost \$600,000
- Reduction in lodging expenses of over \$270,000

That's proof in numbers.

MADE FOR MOBILE

If there was one technology that was made for business travel, it's the mobile device. And the use of mobility is an important characteristic in "best-in-class" organizations, as well. According to the Aberdeen Group, business travelers in 42% of the "best-in-class" organizations had mobile technologies in place compared to 28% in the "laggard" organizations. The research also found that "the average user of mobile technology saves over three hours per month of productivity by directly leveraging a mobile expense management application or portal."

Concur is leveraging the power of mobile to enable organizations to manage anything expense or travel related, wherever their users are. From booking and managing itineraries to capturing receipts and submitting expense reports, mobile technology makes business travel much easier.

#### REAL-TIME INSIGHT: THE IMPORTANCE OF INTEGRATION

According to the Aberdeen Group, "best-in-class" organizations are 50% more likely to have real-time visibility into travel spending against corporate budgets and 57% are more likely to have real-time visibility into pre-trip travel against corporate budgets. If we think back to the company in our opening

scenario, one can understand the importance of real-time insight. A fine-tuned expense management solution—when integrated with the ERP—can be instrumental in helping you track and analyze T&E data across your business. Access to enterprise-wide spending trends and other types of information (coupled with your policies and processes) can drive enhanced business intelligence and increased data visibility.

By taking expense data and breaking it down into pieces, the finance team can get to the detailed information they need to understand the ROI of their travel, even if every trip isn't a sales call.

#### ALL INTEGRATIONS ARE NOT EQUAL

For many companies today, T&E expenses are managed in separate systems—be they simple spreadsheets or a modern travel and expense system. A real challenge is that transactional details that come from these decentralized systems often roll up to the general ledger (GL) in an aggregated format before being posted as journal entries. This typically leaves the GL with a high-level view of a few large T&E categories—like airfare, hotels, meals and mileage—and the finance team lacks the rich transactional detail that's necessary for identifying the cause of a budget overage or a worrisome trend in another expense category. Even in situations where all the functionality is delivered by a single vendor, the level of integration can vary.

Reconciling the data coming from those systems with the general ledger is often a manual process involving extensive exports and imports and quite possibly many IT resource hours. Or, on the other end of the spectrum there's a bare minimum (and thus an inadequate) amount of integration. Despite significant technological advances in budgeting, forecasting and compliance, revenue and expense reporting is still a time-consuming manual process for smaller companies or a less-than ideal and error-prone data transfer for larger organizations. This burdens the finance team with inefficient workloads as they struggle to make sense of the numbers they can see and form hypotheses about those they can't. But there's light at the end of the tunnel. The key is to provide a bi-directional data integration between the travel and expense management solution and the back-end ERP system.

### The End of T&E Data Darkness

The key difference between a "siloed" approach and a "travel-aware" approach is the level of integration between the systems. Modern travel and expense management systems are designed to manage the critical T&E expense line item and the complexities that come with a company's unique travel processes including country-specific regulations and requirements, policies and reporting, and expense reimbursement practices. It makes sense to manage the complexities of travel and expense process in a system that's designed to accommodate those concepts and can easily adjust to changes in travel booking policies and providers, currency exchange, VAT calculations and other travel and expense-related data while keeping GL account allocation current. But the ERP system needs to see that detail in real-time, as well.

### BUT WHAT ABOUT T&E EXPENSE THAT'S (GULP!) OUTSIDE OF THE TRAVEL AND EXPENSE SYSTEM?

In spite of travel managers' best efforts to design the most ideal travel program possible for their company, every travel management program has bookings that take place outside of policy. These outside bookings are referred to as "leakage," and they represent an ever-increasing challenge for today's managed travel programs. Industry data shows that up to 40% of travelers book outside of their company's traditional process (PhoCusWright 2012. These activities cause breakdowns and gaps in the complete data that travel managers need for their CFOs.

To bridge the gap between the apps travelers love, the autonomy they want, and the control business needs, add TripLink from Concur to your integrated

#### Case Study: TEMPLE UNIVERSITY

Temple University, founded in 1884 in Philadelphia, is the 25th largest research University in the United States. Faculty and staff on five major campuses across 17 schools and colleges submit 18,000 expense reports annually.

An initial plan to add a T&E module to the University's new ERP proved unsuccessful.

"As we began to roll out the expense reporting module of our ERP system, it became apparent that it would not scale up to an institution the size of Temple. Rather than continue, we chose to look to implement Concur's automated travel and expense solution," stated Temple's Associate Controller Patricia Russo, MBA, CPA.

  potentially negotiate volume discounts for air, hotel and car rental in the
  future.

"For the first time, we will know precisely what and where we're spending," Russo said.


#### **IMPROVED CASH POSITION**
